

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF PEMBROKE PARK, FLORIDA, AMENDING ARTICLE V OF CHAPTER 15 ENTITLED LICENSES AND BUSINESS REGULATIONS; CREATING A NEW SECTION 15-104 TO ESTABLISH LIMITS ON THE HOURS OF BUSINESS ACTIVITIES OR SERVICES BY MASSEUSES, MASSEURS, OR BATH AND MASSAGE PARLORS WITHIN THE TOWN LIMITS; PROVIDING FOR INCLUSION IN THE CODE OF ORDINANCES; PROVIDING FOR SEVERABILITY; SUPERSEDING CONFLICTING ORDINANCES AND RESOLUTIONS AND PROVIDING AN EFFECTIVE DATE.

Any person who decides to appeal any decision of the Town Commission with respect to any matter considered at this meeting will need a record of the proceedings and, for such purpose, may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
